#### **PURPOSE:**

The intent of this clinical policy is to provide coverage guidelines for dressing supplies.

Please refer to the member's benefit document for specific information. To the extent there is any inconsistency between this policy and the terms of the member's benefit plan or certificate of coverage, the terms of the member's benefit plan document will govern.

### **POLICY:**

Benefits must be available for health care services. Health care services must be ordered by a provider. Health care services must be medically necessary, applicable conservative treatments must have been tried, and the most cost-effective alternative must be requested for coverage consideration.

#### **COVERAGE:**

- I. Primary and secondary dressings and supplies with a valid prescription specific to the dressing being requested for one of the following significant conditions/injuries and, if applicable, are not included as part of the surgery billing or included in a global package
  - A. Burns second and third degree
  - B. Open wounds caused by or treated by a surgical procedure
  - C. Open and/or infected wounds
  - D. Decubitus ulcers Stage II, III, and IV
  - E. Treatment of debrided wounds, regardless of type of debridement

[Note: Sterile gloves are covered if required for the condition/injury being treated]

- II. Primary and secondary dressings and supplies must be billed/provided by either of the following
  - A. A contracted DME vendor who carries a full line of DME equipment; or
  - B. A home health agency, urgent care, physician or facility.

## **EXCLUSIONS** (not limited to):

### **DEFINITIONS:**

### **Primary Dressings:**

Therapeutic and protective coverings applied directly to a wound or lesion.

# **Secondary Dressings:**

Dressing supplies used to secure the primary dressing.
