### I. Length of Authorization

Coverage is provided for 6 months may be renewed.

### II. Dosing Limits

#### A. Quantity Limit (max daily dose) [NDC Unit]:

- Fasenra 30 mg single-dose prefilled syringe
  - Load: 1 syringe every 28 days for 3 doses
  - Maintenance: 1 syringe every 56 days
- Fasenra Pen 30 mg single-dose autoinjector
  - Load: 1 autoinjector every 28 days for 3 doses
  - Maintenance: 1 autoinjector every 56 days

#### B. Max Units (per dose and over time) [HCPCS Unit]:

- Load: 30 billable units every 28 days for 3 doses
- Maintenance: 30 billable units every 56 days

### III. Initial Approval Criteria <sup>1</sup>

Coverage is provided in the following conditions:

- Patient is at least 12 years of age; **AND**

#### Universal Criteria <sup>1</sup>

- Will not be used in combination with other anti-IgE, anti-IL4, or anti-IL5 monoclonal antibody (e.g., omalizumab, mepolizumab, reslizumab, dupilumab, etc.); **AND**
- Must NOT be used for either of the following:
  - Treatment of other eosinophilic conditions (e.g., allergic bronchopulmonary aspergillosis/mycosis, Churg-Strauss syndrome, hypereosinophilic syndrome, etc.)

- Relief of acute bronchospasm or status asthmaticus; **AND**

#### **Severe Asthma † 1,2,5,7,8,9,11**

- Patient must have severe\* disease; **AND**
- Patient must have asthma with an eosinophilic phenotype indicated by blood eosinophils  $\geq 150$  cells/ $\mu$ L within 6 weeks of dosing; **AND**
- Must be used for add-on maintenance treatment in patients regularly receiving BOTH of the following:
  - Medium to high-dose inhaled corticosteroids; **AND**
  - An additional controller medication (e.g., long-acting beta agonist, leukotriene modifiers, etc.); **AND**
- Patient must have two or more exacerbations in the previous year requiring daily oral corticosteroids for at least 3 days (in addition to the regular maintenance therapy defined above); **AND**
- Baseline measurement of at least one of the following for assessment of clinical status:
  - Use of systemic corticosteroids
  - Use of inhaled corticosteroids
  - Number of hospitalizations, ER visits, or unscheduled visits to healthcare provider due to condition
  - Forced expiratory volume in 1 second (FEV<sub>1</sub>)

**\*Components of severity for classifying asthma as severe may include any of the following (not all inclusive):<sup>2,9</sup>**

- Symptoms throughout the day
- Nighttime awakenings, often 7x/week
- SABA use for symptom control occurs several times per day
- Extremely limited normal activities
- Lung function (percent predicted FEV<sub>1</sub>) <60%
- Exacerbations requiring oral systemic corticosteroids are generally more frequent and intense relative to moderate asthma

#### **IV. Renewal Criteria 1,7,8**

- Patient continues to meet the universal and other indication-specific relevant criteria identified in section III; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: parasitic (helminth) infection, severe hypersensitivity reactions (e.g., anaphylaxis, angioedema, urticaria, rash), etc.; **AND**
  - Improvement in asthma symptoms or asthma exacerbations as evidenced by a decrease in one or more of the following:
    - Use of systemic corticosteroids
    - Two-fold or greater decrease in inhaled corticosteroid use for at least 3 days

- Hospitalizations
- ER visits
- Unscheduled visits to healthcare provider; **OR**
- Improvement from baseline in forced expiratory volume in 1 second (FEV<sub>1</sub>)

## V. Dosage/Administration <sup>1</sup>

Indication	Dose
Severe Asthma with eosinophilic phenotype	Administer 30 mg subcutaneously every 4 weeks for the first three doses and then once every 8 weeks thereafter.
